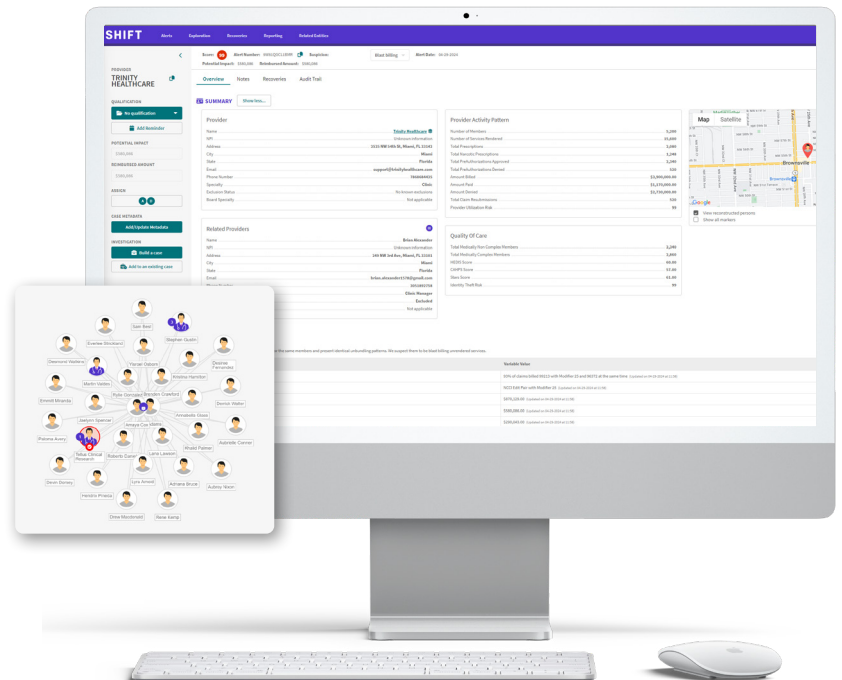
Real-Time Integration
